REGULATORY UPDATES

Massachusetts: OSHA has issued a proposed rule to approve a new occupational safety and health plan (state plan) for Massachusetts state and local employers and their employees. Under the Occupational Safety and Health Act, state and local government employers are specifically excluded from federal coverage. However, the Act provides for States to assume responsibility for occupational safety and health programs under the State's own plan, which must be approved by OSHA and at least as effective as the federal program. Each State Plan must include coverage of state and local employees. If approved, Massachusetts would be the newest OSHAapproved State Plan for state and local government employees and would cover approximately 6,500 public sector employers and nearly 434,000 public employees throughout the state. Private sector and federally employed workers would remain under federal OSHA jurisdiction. Comments and requests for an informal hearing will be accepted for 30 days following publication electronically at www.regulations.gov, which is the Federal e-Rulemaking Portal.

EPA: June 15th, 2022 – SWANA co-signed a letter to the USEPA supporting policy and practical solutions that will accelerate the cleanup of PFAS in the environment yet urging the agency to evaluate the unintended consequences of designating PFOA and PFOS as hazardous substances under CERCLA. If the Agency moves forward with this action, it could have direct negative economic impacts to owners and operators of

landfill, water systems, and wastewater systems, public and private. These impacts would be felt across the spectrum and eventually to the many households and businesses that rely on our services. SWANA and many other agencies stand ready to engage with the Agency to develop sound and comprehensive rules to protect human health and the environment and avoid unintended consequences.

TRAINING OPPORTUNITIES

The SNE Chapter will be launching a self-study training event in the second half of 2022 that will consist of on-line learning partnered with weekly meetings to discuss the material and to hear from guest speakers to discuss real life situations. At the conclusion of the training attendees will be able to take the associated SWANA exam and become certified in the subject matter. We are nearing the end of the planning stages and will be rolling out details in the next few weeks. - City of Springfield, MA The Massachusetts' Springfield Materials Recycling Facility (MRF) unveiled Me and My Bin, a video about the important roles MRFs and individuals play in maintaining a strong U.S. recycling program.
- Maine recently passed <u>LD 1639</u>, limiting the amount of waste a facility can accept from out of

the State. This rule may have an impact on the overall solid waste disposal market for the remainder of New England.
