BOARD ELECTIONS

REGULATORY UPDATES

Massachusetts: New MADEP Waste Bans go into effect on November 1, 2022. Is your company ready? If not reach out to one of our many firms represented by our Board and Chapter members to assist you in preparing for these changes.

EPA: USEPA has issued the final NPDES General Permit for Dewatering and Remediation Activity Discharges, effective August 31, 2022. Please review your permit

activities and talk to your consultants to ensure you are covered and have the appropriate measures in place.

PFAS: The Environmental Protection Agency (EPA) has issued a [pre-publication version](#) of a proposed rule to designate two PFAS compounds as hazardous substances under the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA). This rule has the potential to increase liability at many solid waste disposal facilities. SWANA Executive Director & CEO David Biderman continues to work through the staff and Technical Divisions to comment on these potential rules to inform the various agencies of the issues this will pose to our industry. SNE Chapter encourages all our members to review these rules and submit comments as appropriate to your legislative members.

TRAINING OPPORTUNITIES

The SNE Chapter is collaborating with MassRecycle to offer a unique training opportunity for the SWANA Zero Waste Management Course. While this will be a self-paced course, we will be holding weekly sessions and guest speakers to discuss real life situations and offer their valuable insights into application of the course material. At the conclusion of the training attendees will be able to take the associated SWANA exam and become certified in the subject matter.
